## General Winter 2022 student life updates

Alex: I had a meeting with Karen Drake. It was frustrating because of York. Basically, there is no change in York policy. She is basically being ghosted by York. Starting next semester, TUUS will no longer need a comprehensive application to hold events off campus; they will only require notification of these events. They want to have a due diligence process to ensure that the planners of the event take all precautions necessary.
